As part of the Rural Start-Up Fund, there is also the opportunity to receive mentoring support from a relevant expert in the Forest Holidays team for 12 months to further assist and support the successful applicant(s). Related areas of expertise include but are not limited to agriculture, animal care, environmental conservation, equine, farriery, food production, forestry, landscaping, land-based engineering and Land Management.

To apply, you must be:

- Aged 18 and over.
- A UK citizen and resident in the UK.
- Embarking on a new rural business/enterprise start-up venture.
- Able to demonstrate how your business will, in some manner, support rural communities, promote conservation of the countryside, or support rural sustainability.

Terms and Conditions

1. The closing date for entries is 12pm (midday) on Monday 25th October 2021. Applications received after the closing date will not be accepted.
2. Applications will be judged by a panel of assessors from Forest Holidays and The Prince's Countryside Fund. For those shortlisted, interviews will take place via video call during the week commencing 8th November 2021.
3. The successful applicant(s) will be invited to a launch event on Wednesday 24th November 2021. Wednesday 24th November 2021 at Forest Holidays' Forest of Dean, Bracelands Drive, Christchurch, Coleford, Gloucestershire, GL16 7NN.
4. Successful beneficiaries will be asked to support the promotion of the Rural Start-Up Fund in following years by submitting media and written content as requested. Applicants may also be asked to attend open days with Forest Holidays and The Prince's Countryside Fund.
5. One successful beneficiary will receive up to £5,000, or the sum will be divided between a number of successful applications. This will be at the discretion of Forest Holidays and The Prince's Countryside Fund to ensure the best use of the funding.
6. Successful beneficiaries will receive mentoring support from the Forest Holidays team for 12 months.
7. Successful beneficiaries will be asked to submit a report to Forest Holidays and The Prince's Countryside Fund at the 6-month mark and again at the end of the year, outlining what their funding

has been spent on. If it is decided that spending is inappropriate, Forest Holiday holds the right to discontinue financial and mentorship support.
